

CHILDREN, COVID-19 AND THE SUMMER OF 2021.

For everybody, this summer could be like all other summers. In principle, as far as Covid -19 is concerned, there is no reason for extra worries nor about your own health, neither for that of your children or for those in your direct vicinity. For people under 70 the IFR (the Infection Fatality Rate – the chance of dying because of the illness) is $0.13\%^1$ which is similar to that of influenza. For children, adolescents, and young adults, the IFR is practically zero².

The best protection against infections is a healthy diet and (outdoor) sports.

Every jab should be optional certainly when there is even the slightest possibility of harm and unwanted side effects. It is your own responsibility, that is why we advise parents and their children to discuss this subject together and get yourselves informed. Because the information given by the authorities is incomplete it is advisable to do your own research and contact the local and national vaccination critical organisations³.

The Covid-19 injections are made using gene technology, a new (GMO) technology which has a different impact than traditional vaccines. They have not been approved but allowed on the marked (for emergency use) after just three months of trial. In phase 3 and 4 of the trials, which last until December 2023⁴, the long-term effects are studied. Only then there will be better details known as to the safety of the injections.

Animal trials have been bypassed. Past attempts to use gen technology to developpe vaccines, failed; all the 'vaccinated' mice died when subsequently exposed to the wild virus. From spring 2020 onwards we were warned about the possibility of a strong immune response – immune enhancement (ADE Antibody Dependent Enhancement)⁵. So what will happen this coming autumn?

The recording and reporting of all the side effects should thus have the highest priority, but unfortunately, only 10% of all the side effects are reported. Worldwide millions of people have received the injections. In the Netherlands alone 440.266 side effects have been reported: epileptic attacks, blood clots, brain disorder (*neurological disorder*)⁶, myocarditis⁷, en 409 deaths⁸ (6-22-2021).

Also children and adolescents risk permanent damage and even death from the injections. Healthy children hardly become ill from the virus. Even though officially permission is only given for injecting the 18+ age group, the EMA -data base Eudra-Vigilance reports 19 deaths in the age group of 0–17-year-olds and 2122 serious adverse events⁹. The Pfizer vaccine insert reports that children in the age of 12-16 have a 0.4% chance of serious side effects¹⁰. In the inserts¹¹ deaths are (as yet) not mentioned.

Having had Covid-19, even mildly¹², produces long lasting, possibly even lifelong immunity¹³, also for the mutations of Sars-Cov-2. A healthy and alert immune system ensures that the virus and the infected cells are disposed of.

All adults and in the near future also adolescents and children are pushed to have the injections before the summer on the pretext of regaining their freedom. First the government imposed all kinds of restrictions which turned out ineffective and thus limited our constitutional fundamental rights of freedom, which now can be reclaimed by having the jab. Why this haste just before the summer?

We advise you to consider postponing the jap until the end of 2023 or at any rate until October 2021.
